Resident Bill Garvey addressed the proposed paving of the five streets in the southend of the Village and is supportive of the project.

He notified Trustee Nicoll and Harris that they will both be receiving letters from him with different subject topics.

Mr. Garvey stated that he noticed that the freight train did not blow the whistle going over the crossing and he did notify the Menands Police Department that this didn't take place.

He also agreed with resident Laura Harbour's concerns about the trains at the crossing.

Laura Harbour continued to express her concerns over the stopped trains blocking the crossings. Police Chief O'Brien addressed her concerns. Ms. Harbour felt that if the Village would at least issue some tickets, then it would be a good message to send to the railroad.

She also inquired about the position of the camera on the tracks and Chief O'Brien responded.

Ms. Harbour informed the Board that the NYS Department of Environmental Conservation rescinded the permit to Global, to transport the heavy oil through the Menands Community.

Resident Brian Marsh requested that the Village add information in the Menands Activities Newsletter on the Adopt-A-Highway Program, and he would like to work with others in the community on this project.

Resident James Sher wanted to thank the Board for the clean-up of the Cemetery Avenue Creek.

He also asked the Board if they are going to look at Schuyler Inn and if anything can be done about it.

Mr. Sher also informed the Village that the property on 20 Louis Avenue is a mess. He said that the property is currently being used as a boarding house and that there is a camera in the window monitoring the property.

Resident Dave Blaauboer notified the Board that his property was reclassified as a Class A Flood Zone by FEMA and he would have to get flood insurance. He has lived at the same property for 69 years and has never had a flood.

Resident Kirk Montanye asked if anyone was looking at putting speed bumps on South Lyons Avenue.

Mr. Montanye also inquired as to why the proper information wasn't included on his denial letter to his FOIL request as to who the Village's Appeals Officer is. He feels that the information should have been provided.

Trustee Harris asked Mr. Montanye to please watch his language and tone of voice since there was a family with children in attendance. Mr. Montanye apologized.

Resident Diane Brunelle asked if the Menands Fire Company would be cooking for those attending the Park Concerts.

Mayor Grenier stated that she addressed the subject with Mr. Montanye at the last meeting and the Fire Company would be working the concerts.

Chief O'Brien introduced Louis Romano who comes from Ilion, as the Village's newest Police Officer. The Chief also remarked that he has been very pleased with the performance of his work.
