In addition to the Building Permit Application, three (3) sets of detailed design drawings, three (3) copies of a survey, a single copy of any fully executed construction contract(s), the Insurance Form and the building permit fee must be submitted simultaneously.

This application must be completed by the Owner of the property on which construction is to occur, or by a duly authorized representative of the Owner of the property. In submitting this application, the applicant swears that any and all information and or statements contained in this application are true, to the best of the applicant's knowledge. Any information that the applicant has set forth in this application that is false or misleading may result in the rejection of the application. Construction authorized by this permit must always comply with the plans as approved by all applicable government agencies.

For details on any supplemental applications, plans, drawings or documents, please refer to the general FAQ Sheet, or the information sheets that correspond to each individual supplemental application. Below, find a check list for the applicant to complete prior to submission of this application.
